- 1. Where fragments or residues of specimens that fall to the floor of the test chamber continue to burn for more than an average of 2 seconds per specimen for the sample of 10 specimens, the material shall be recorded as failing. (Flaming Drip)
- Where the average weight loss of the 10 specimens in a sample is greater than 40 percent, the material shall be recorded as failing. 2.
- Individual specimens will be listed as a failure if it exceeds mean + 3 SD 3.
- Where the specimens do not demonstrate performance in accordance with either of the conditions indicated above, the material shall 4. be recorded as passing this test and shall be designated as flame resistant.
